These instruments having been examined and found to be in due form, the exchange was executed.


IN WITNESS WHEREOF, the undersigned have signed the present process-verbal.

इन दस्तावेजों की जांच करने तथा ठीक पास जाने के बाद आदान-प्रदान किया गया ।



NOW, THEREFORE, I, NEELAM SANJIVA REDDY, President of India, do herewith by these Presents name, constitute and appoint Dr. Pratap Chandra Chunder, Minister of Education, Social Welfare and Culture, as the Representative of the Government of India having Full Power and Authority to sign the said Agreement on behalf of the Government of India.
