

It is certified that the above amount of Rs.13,500/- (Rupees thirteen thousand and five hundred only) is being laid in accordance with the pattern of assistance as agreed to by the Ministry of Finance and the Government of Maharashtra. According to this pattern, the Government of India would bear 50% of the recurring expenditure and 2/3<sup>rd</sup> of the recurring expenditure on the Delivery of Books Act Section of the State Central Library, Mumbai.

3. The Grant is subject to the compliance of all the codal as well as administrative formalities.

4. The above amount is debitible to Demand No.19, Ministry of Culture, 3601-Major Head Grant-in-aid to State Government 01 Non-Plan Grants(Sub Major Head) 202-Art and Culture – Public Libraries(Minor Head), 02-Central Library, Mumbai, 02.00.31-Grant-in-aid General under Non-Plan for the current financial year 2014-15.


5. The amount of Rs.13,500/- (Rupees thirteen thousand and five hundred only) will be placed at disposal of the State Government by the Principal Accounts Officer, Ministry of Culture through RBI, Central Accounts Sectt., Nagpur as early as possible but in any case not later than 31.03.2015.
